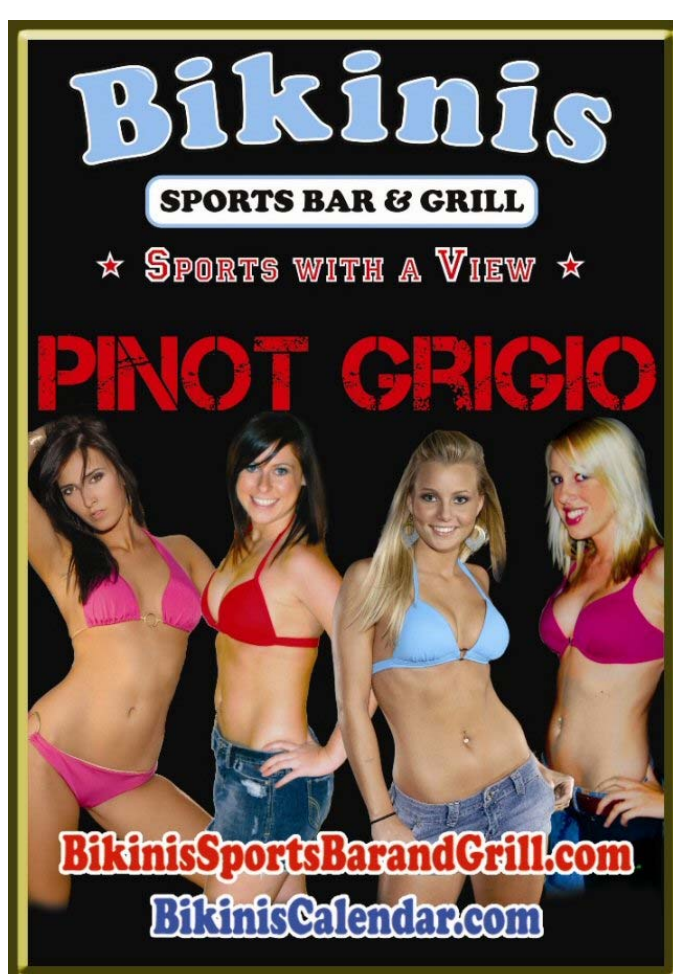


Image Type: Brand (front)
