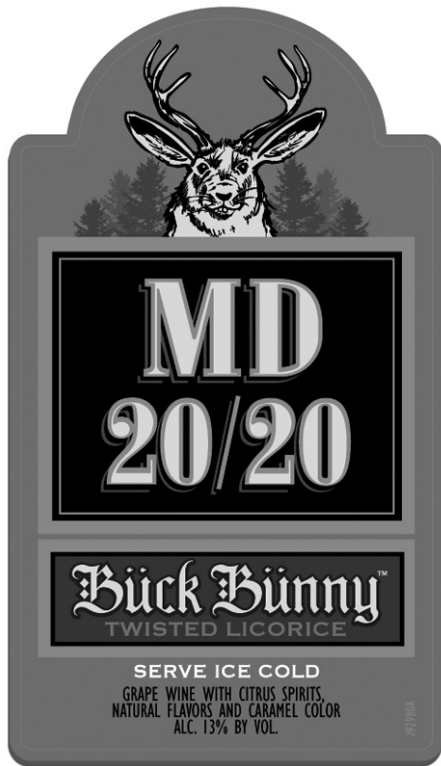


Image Type: Back
