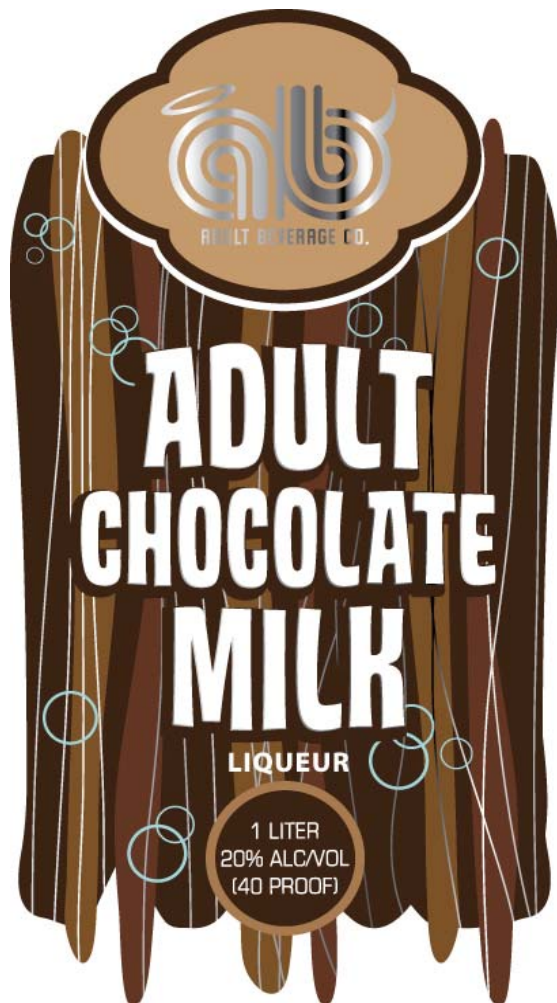


Image Type: Neck
